Dear Steve,

could I express the thanks of the members, management committee and staff of Princetown Pavilion Youth Club for the Parish Council's significant contribution to our project development fund.

The signed agreement should be on its way back to you as you receive this email.

With reference to the requirements of last years grant to support utility costs, I am please to confirm that discussions with both of our energy providers resulted in new tariffs that are projected to save us in the region of £1,000 per annum. I think the previous tariffs had been in place some time!

Management systems and controls on the consumption of energy have also been put in place, with boiler repairs and better thermostat controls installed, together with heating level policies and actions.

We now wait to see if the savings from last winter, which was quite mild, can be sustained over this coming winter.
